BOOKS CLOSE OCTOBER 9TH, 2012 FOR THE NOVEMBER 6TH, 2012 GENERAL ELECTION

NOTE: IF YOU HAVE MOVED OR CHANGED YOUR NAME PLEASE TAKE THE TIME TO MAKE THESE CHANGES WITH THE SUPERVISOR OF ELECTIONS OFFICE BEFORE GOING TO VOTE. THIS WILL HELP WITH ANY BACKUP IN LINES DURING EARLY VOTING AND ELECTION DAY.

IF YOU HAVE MOVED INTO SUMTER COUNTY FROM ANOTHER COUNTY AND HAVE NOT CHANGED YOUR ADDRESS PLEASE DO SO BEFORE GOING TO VOTE. IF YOU DO NOT CHANGE YOUR ADDRESS YOU WILL HAVE TO VOTE A PROVISIONAL BALLOT. YOU CAN CHANGE YOUR ADDRESS AS EASY AS CALLING THE OFFICE AT 352-569-1540, PLEASE DO SO NOW.

NOTE: PLEASE HAVE YOUR PHOTO AND SIGNATURE IDENTIFICATION WITH YOU WHEN YOU GO TO VOTE. IF YOU DO NOT HAVE PHOTO AND SIGNATURE IDENTIFICATION, YOU WILL BE ALLOWED TO VOTE A PROVISIONAL BALLOT. THE CANVASSING BOARD WILL DETERMINE ELIGIBILITY.

UPDATE VOTER SIGNATURE
