

# VOTE BY MAIL

## Why Vote by Mail?

- It's Fast, Easy and No Waiting In Line!
- Any registered voter can vote by mail
- You don't need a reason

## How do I request Vote by Mail?

- Complete the online request at: [www.sumterelections.org](http://www.sumterelections.org) or
- Pick up a request form at the county elections office; or call (352) 569-1540
- You MUST request a Vote by Mail ballot no later than 5pm the Wednesday prior to the election

## Can I track my Vote by Mail?

- You can track the status of your request online using the Free Access System
- Go to <http://www.sumterelections.org>
- Click the "My Registration Status Lookup" button
- Fill in the requested information
- Click SUBMIT
- You should then be able to see your registration information
- Click "Show my Vote by Mail Ballot Information"
- You will see when your ballot was mailed and also when your completed ballot is received back in the office for processing

## When will I receive my Vote by Mail Ballot?

- Ballots are mailed out 28-35 days before each election

## What do I need to do to complete it?

- CAREFULLY follow the instructions that come with the ballot
  - complete it & SIGN YOUR ENVELOPE
  - return it to the Supervisor of Elections office no later than 7 PM on Election Day
  - It cannot be accepted at a Polling Location

## How is my vote kept confidential?

- The elections office compares your signature on the outside of the envelope with your signature on file with the office
- The envelope and ballot are separated before your ballot is counted to preserve the secrecy of your vote

## Other Important and Helpful Information:

- If you decide that you would prefer to vote at the polls:
  - Take your vote by mail ballot to your polling location
  - It will be cancelled and another ballot issued to you
