Florida statutes require that all poll workers:

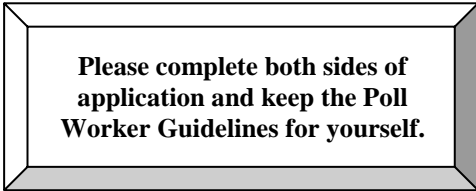
- ❖ Attend training before **EVERY** election (per F.S. 102.014).

- ❖ Be registered to vote in Sumter County.
- ❖ Be 18 years of age.

In addition, the poll worker is expected to:

- ❖ Attend on Election Day from 5:30 am until work is completed after the closing of the polls at 7:00 pm.
- ❖ Lift and assemble 20 lb. voting booths.
- ❖ Be willing to deal with the public in a courteous, patient, and efficient manner.
- ❖ **Must be willing to work at any precinct in Sumter County.**

Oath: I do solemnly swear (or affirm) that:

I am not a convicted felon, or if I am, my rights relating to voting have been restored.
If I am duly appointed as a poll worker, a deputy, or alternate in Sumter County, I will faithfully perform my duties to the best of my ability and according to the Election Laws of the State of Florida.
