## WHY UPDATE YOUR SIGNATURE?

Voters may update their signature at any time using a voter registration application. ✦ Call or visit your local elections office, library, post office, school or other government office for an application. ✦ Deliver your completed application to our main office location (address on back of brochure). ## WANT TO UPDATE YOUR PARTY?

Your Party must be updated by submitting: (1) a voter registration application or; (2) a signed written request including all required information, per F.S. 97.1031, **AND**

**MUST BE COMPLETED BY THE BOOK CLOSING DEADLINE FOR EACH ELECTION.**
